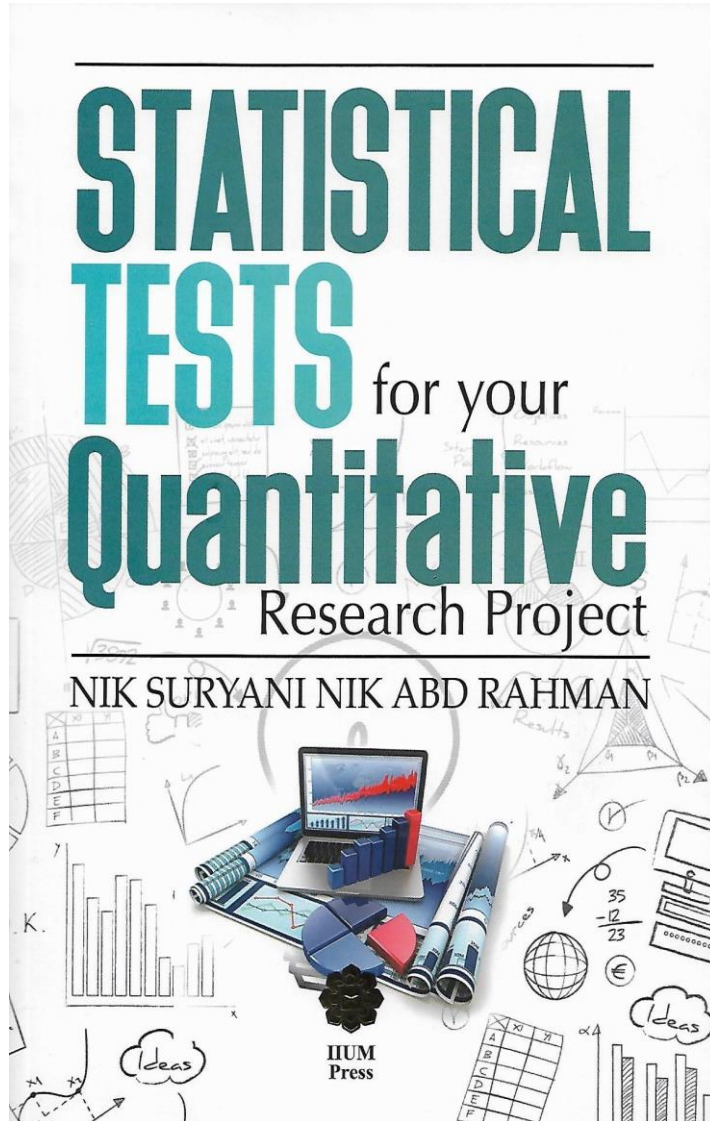

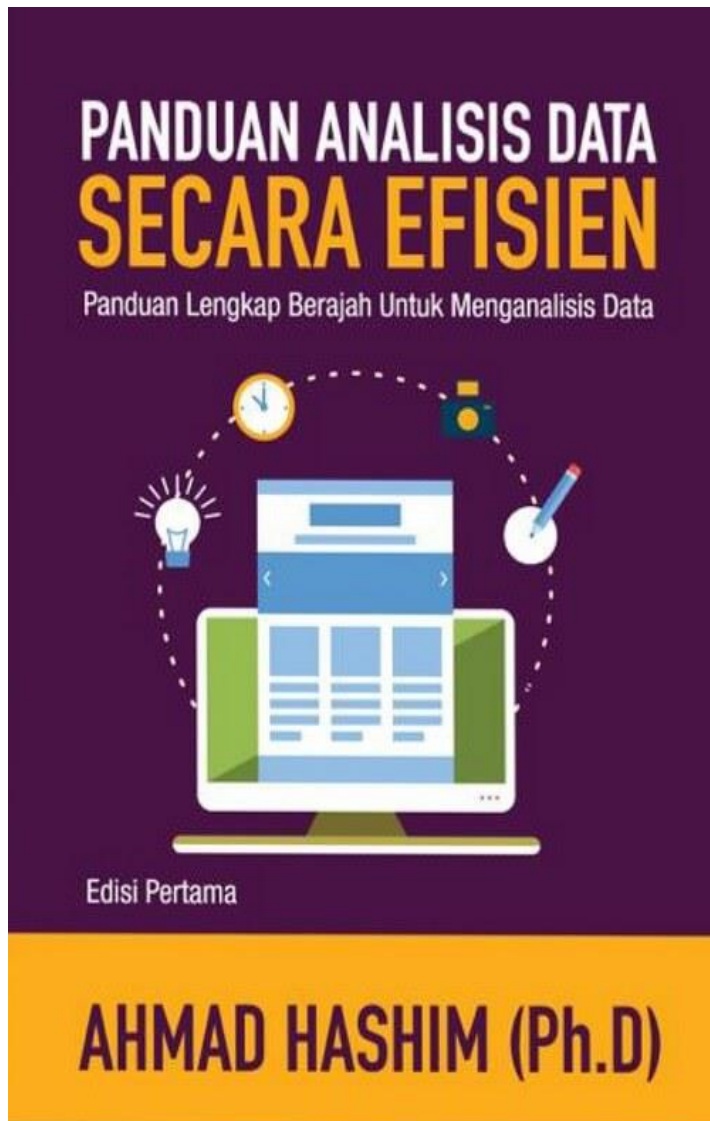
STATISTICAL TESTS FOR YOUR QUANTITATIVE RESEARCH PROJECT

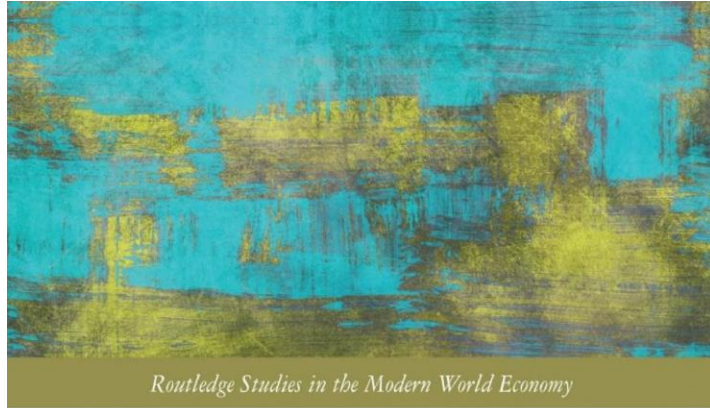


This book addresses several issues in developing the Islamic microfinance institutions. The most challenging issues for microfinance institution is between exclusion and inclusion.

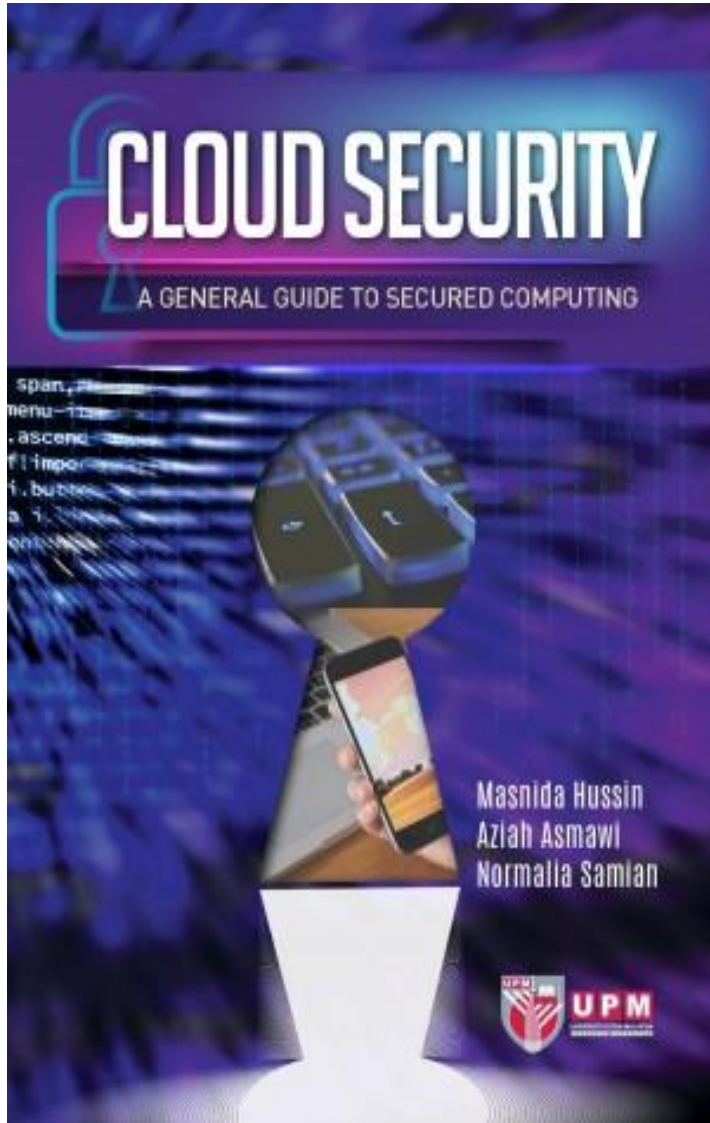

This book focuses on concept, implementation, and analysis for those who want to study Cloud security.

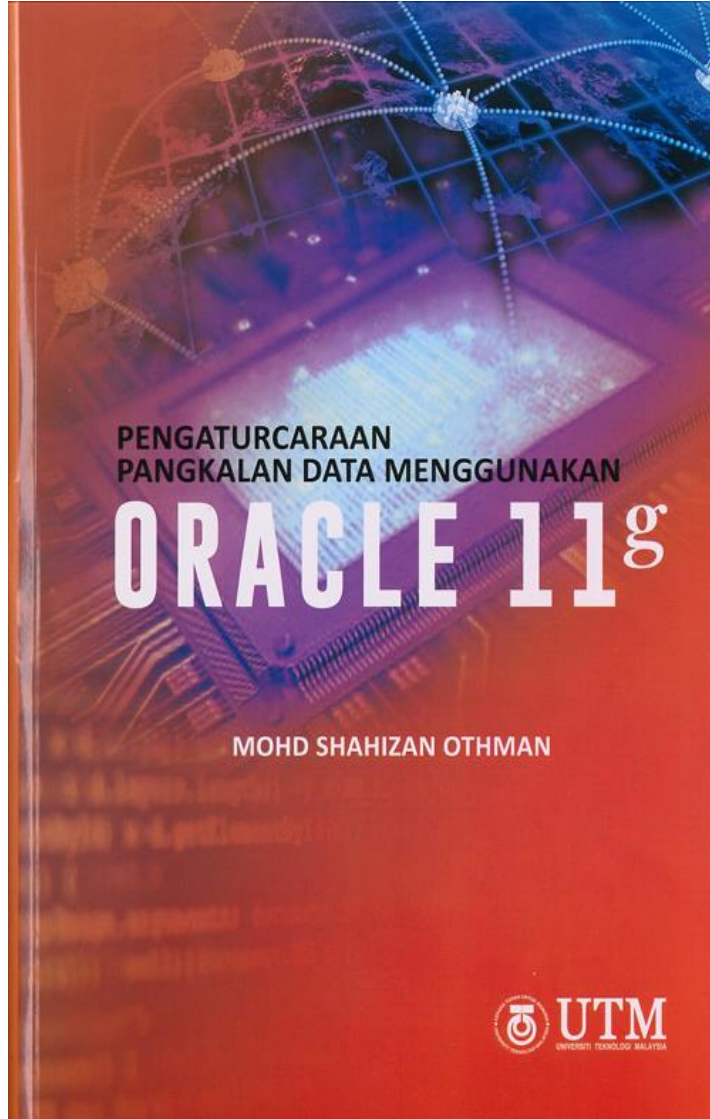

Optimistically, this book able to help the readers to gain the scope of Cloud security at glance but comprehensive.

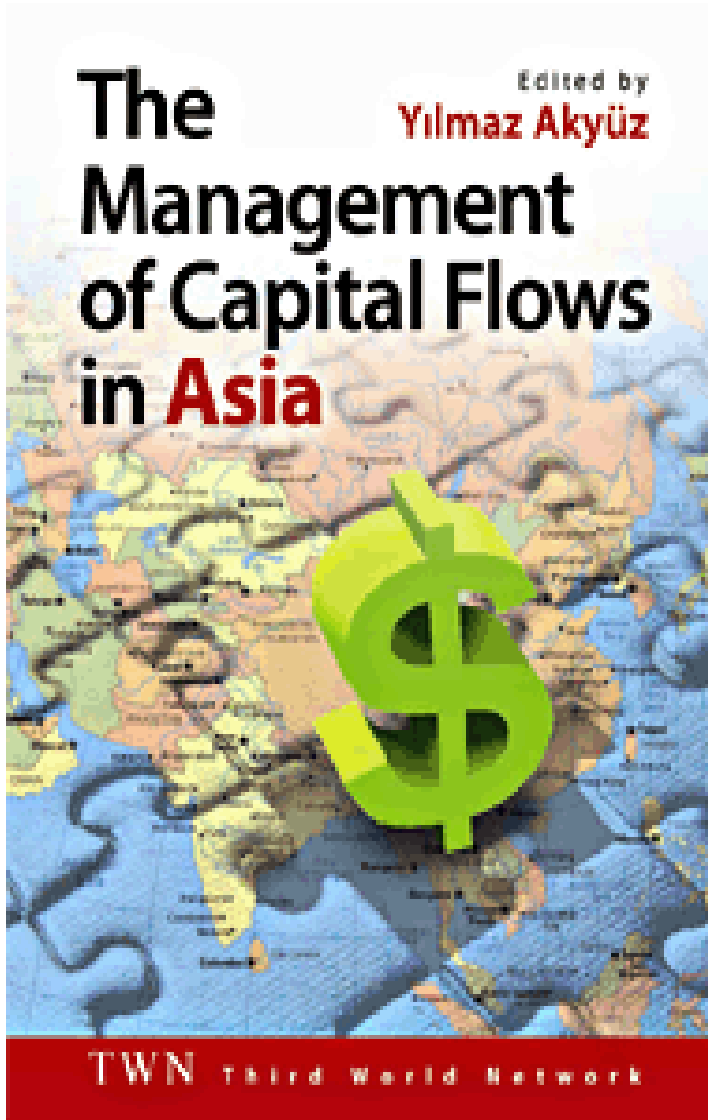


PENGATURCARAAN PANGKALAN DATA MENGUNAKAN ORACLE 11G

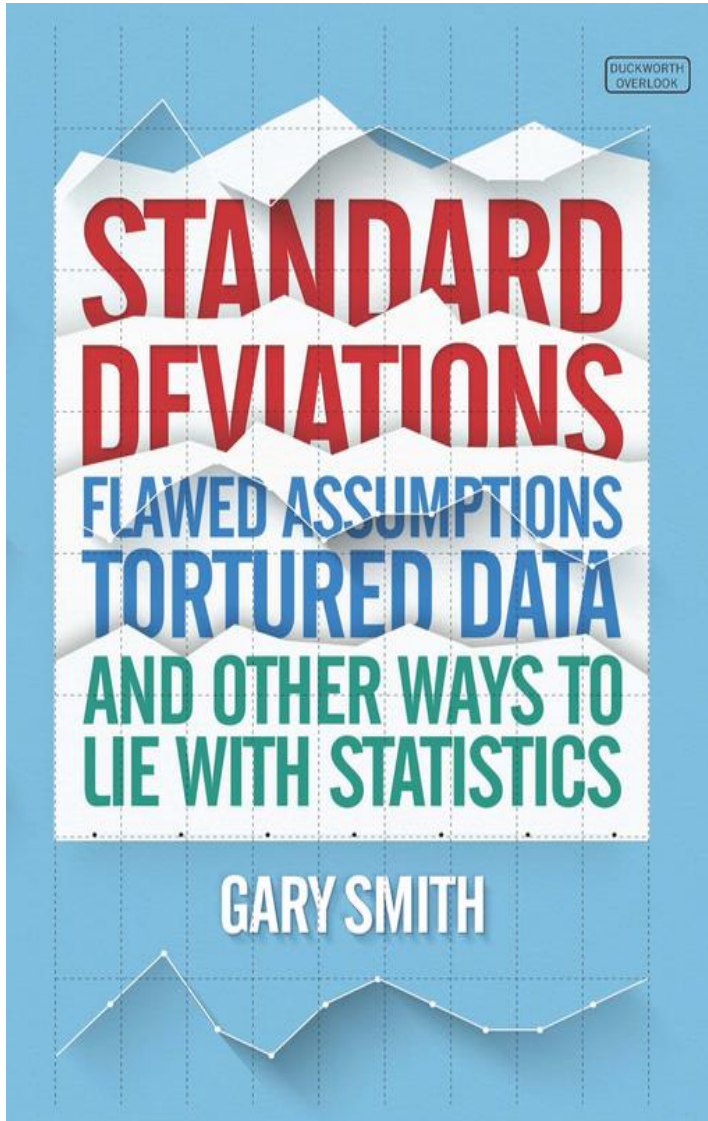


The 1997 Asian financial crisis brought home to the region's economies the importance of managing capital flows in order to avert financial shocks. This book looks into whether and how this lesson was taken on board by policy makers in Asia and accordingly how capital account regimes in the region evolved in the post-crisis period.

The early years of the new millennium saw a strong surge of capital flows into Asian emerging markets amid conditions of ample global liquidity. In response to the influx of funds these countries generally chose to keep their capital accounts open to inflows dealing with the attendant impacts by liberalizing resident outflows and accumulating foreign exchange reserve.

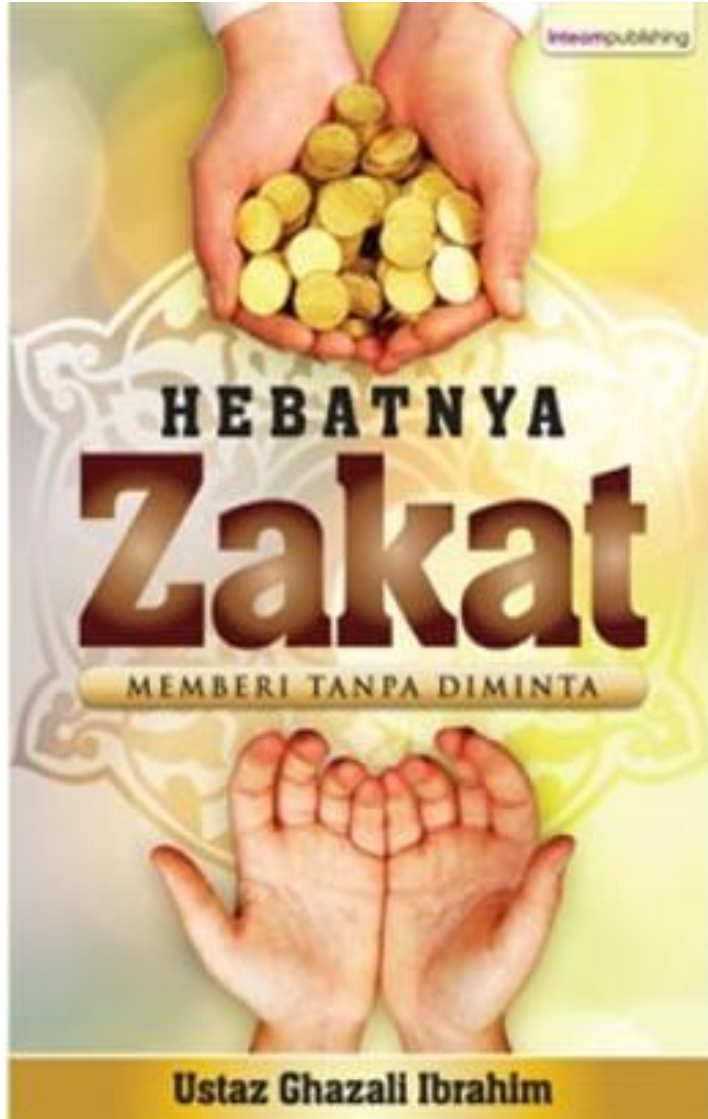


Standard Deviations Flawed Assumptions Tortured Data and Other Ways To Lie With Statistics



Did you know that having a messy room will make you racist? Or that human beings possess the ability to postpone death until after important ceremonial occasions? Or that people live three to five years longer if they have positive initials, like ACE? All of these 'facts' have been argued with a straight face by researchers and backed up with reams of data and convincing statistics. As Nobel Prize-winning economist Ronald Coase once cynically observed, 'If you torture data long enough, it will confess.' Lying with statistics is a time-honoured con. In *Standard Deviations*, economics professor Gary Smith walks us through the various tricks and traps that people use to back up their own crackpot theories. Sometimes, the unscrupulous deliberately try to mislead us. Other times, the well-intentioned are blissfully unaware of the mischief they are committing. Today, data is so plentiful that researchers spend precious little time distinguishing between good, meaningful deductions and total rubbish.

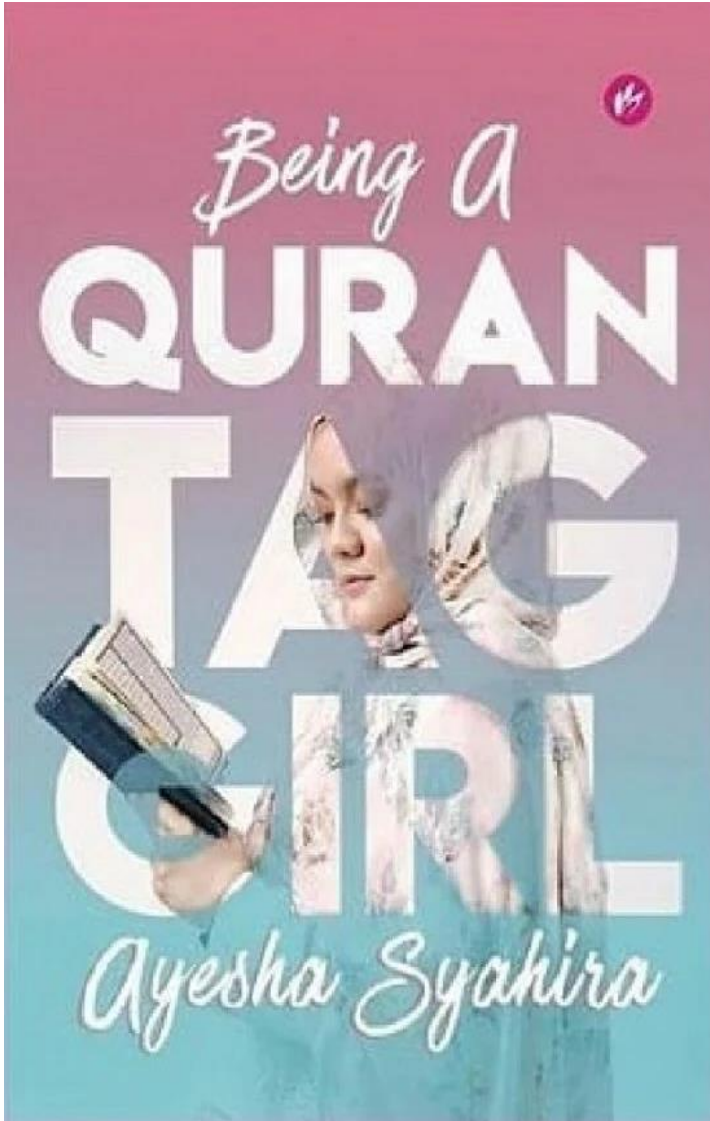
